# Perceptions of Primary School Teachers Regarding the Effectiveness of Parent Teacher Council at Public Sector

## ABSTRACT

The study was sought to explore the perceptions of primary school teachers regarding effectiveness of parent teacher council at public sector. The study's objectives were to analyse primary school teachers' impressions of the organisation structure of the parent teacher council (PTC), to investigate primary school teachers' perceptions of the functions of the PTC, and to determine the efficacy of the PTC (PTC). The population of the study consisted of all 6988 teachers working in 571 government primary schools in the district of Swabi. As a sample, 100 instructors were chosen at random from 25 government elementary schools in the district of Swabi.. A closed ended questionnaire was chosen for data collection. The questionnaire included a variety of questions based on dichotomous. The collection data was analyzed by using percentage as statistical tool. Findings of the study concluded that majority of the respondents replied that there is parent teacher council (PTC) in their school. Most of the respondents were of the opinion that the children of PTC Chairman study at our school. Majority respondents were of the view that PTC member admitted their children in our school. Most of the respondents were of the opinion that the secretary call PTC meeting on proper time. The majority of respondents agreed that the Secretary should preserve a record of PTC meetings. PTC, according to all respondents, plays a role in enhancing students' attendance. PTC, according to half of the respondents, has a role in encouraging students to apply for admission. The majority of respondents believe that PTC plays a role in resolving problems for students and teachers. All of the respondents were of the opinion that PTC funds are utilized in a fair way due to Parent Teacher Council. All of the respondents were of the opinion that PTC is effective in evaluating construction process in schools.

The community's involvement in educational issues affecting the school and children, according to Govinda and Diwan, R., (2005), helps to raise the standard of education. Participation from the community removes obstacles to students' education. It provides a means of eradicating social ignorance and supports the advancement of education.

PTC aimed to enhance children's welfare, acknowledge the importance of parents in their kids' education, actively include parents in their kids' schools, and lower teacher and student absences to build a strong bond between the home and the school in order for parents and teachers to effectively collaborate on the education of the children to enhance the public's ability to communicate with educators in order to support the growth of children's physical, mental, social, and spiritual education (Govt, of Pakistan, 2002).

Aside from the government's proactive efforts to raise literacy rates, Pakistan's Khyber Pukhtoon Khwa province had a total literacy rate of 25%, a female literacy rate of 13%, and a little over 3% in some of the province's less developed districts. Despite the fact that there are 20,000 youngsters in total enrolled in Govt. Primary Schools for children aged 5 to 10, a sizable portion of students are seen to be absent. One-half of the kids admitted to class I do not finish their fifth-grade schooling. Since the KPK government decided to reach a 70% participation by the year 2005, I was to planed that each primary school should have a Parent Teachers Association. Allice McLellan Birney's remarks regarding PTC will be recalled because she is widely regarded as the organization's founder. Future generations will possess a new world and a new population if parents, careers, teachers, ministers, legislators, and most powerful of all, the media, make children as our guiding principle for the present and the future. Among PTC/many PTC's aims is fostering better relationships between parents and teachers so that they can work together for their children's education, and connecting educators with the public to encourage the youth's physical, mental, social, and spiritual development in schools, communities, and places of worship. A national PTC is linked to the first local PTC, for instance, bringing together advocates for youth and children from all over the country. The neighborhood PTC cares deeply about the school and the community. In other

words, it's an assessment of the course of study. The second category of PTC consists of senior citizens who are interested in helping with the development of children under the age of five. The third is a group that represents both parents and students called a parent-teacher-student association. The goal of the PTSA is to help every student reach his or her full potential. In the United States, the fourth type of PTC/PTC is the Special Education PTC, which advocates for the educational rights of all children, including those with special needs. They are committed to helping students grow into effective leaders. That's why they put in extra effort to create tailor-made opportunities for the kids with special needs (www.PTC.org/1162.asp). The local PTC is made up of six people. The association is typically led by a local resident who serves as chairman. A new president, general secretary, and treasurer are selected annually. The leader of the organisation is in charge of the selection process for the PTC. While it is up to the school to decide who will represent the teachers. When ADO gives their final approval, the process is over. PTC funds may be used for educational purposes at the discretion of the PTC's chairman, secretary, and other members (Govt of Pakistan, 2002).

The establishment of PTC benefits not only the kids but also the institution and helps to solve issues at our schools like "Ghost Schools," "Corruption," "Underfunding," "Damaged Buildings," "No Drinking Water," "No Toilets," and "No Playground," among others. Government underinvestment and low lending rates are to blame for these issues, as Pakistan only devotes 1.8% of its GDP to education. PTC offers community members a venue and a chance to get involved and raise the bar for instruction. PTC offers a forum for teachers and parents to work together to meet the needs of the school and the students. Additional community participation is required to strengthen PTC (www.yesPakistan.com).

Sajjad (2006) asserts that PTC supports the school's numerous projects and activities, such as the organisation of social events for students. In addition, it fosters effective parent-school communication, supports other programmes and projects, and helps the school analyse its success through parent teacher developmental sessions (PDM). In addition, the Parent Teacher Council (PTC) and the Orientation Program allow parents and children to communicate with the school's administration, provide comments, and exchange ideas. It is recommended that parents take an active role in the intellectual, social, and emotional growth of their children. The participation of parents as vital partners who proactively contribute to the smooth operation of the school is intended to achieve this goal. There are a lot of benefits that come with getting the community involved in the school administration. It has the potential to make a significant contribution to the overall improvement of the health of the school.
